Dear Mr. Floyd:

This office has reviewed the unexecuted copy of the unit agreement which you have submitted for the proposed East Hobbs (San Andres) Unit Area, Lea County, New Mexico. This agreement meets the general requirements of the Commissioner of Public Lands who has this date granted you preliminary approval as to form and content.

It is our understanding that no fresh water will be used for injection in this project.

Preliminary approval shall not be construed to mean final approval of this agreement in any way and will not extend any short-term leases, until final approval and an effective date have been given.

When submitting your agreement for final approval, please submit the following:

- 1. Application for final approval by the Commissioner setting forth the tracts that have been committed and the tracts that have not been committed.
- 2. All ratifications from the Lessees of Record and Working Interest Owners. All signatures should be acknowledged by a notary and one set must contain <u>original</u> signatures. (The Lessee of Record on State Trust Lands must ratify the unit to commit their tract to the unit.)
- 3. Order of the New Mexico Oil Conservation Division. Our approval will be conditioned upon subsequent favorable approval by the New Mexico Oil Conservation Division.
- 4. A copy of the Unit Operating Agreement.
- 5. A copy of your initial plan of operation, pursuant to Section 11 of the agreement.
- 6. A re-designation of well names and numbers.
- 7. On Exhibit "B", please include for Tract 10, and all other tracts, the correct lease number, lessee of record and complete the land description by including the Township and Range.
