Dear Mr. Wade:

The Commission heard the above-mentioned case this morning. After hearing the testimony and evidence offered by the Oil Conservation Division and reviewing your letters of August 13 and July 11, 2003, the Commission found that it needs additional information to verify the plugging of the following wells: ASU A #001 and Federal #001.

The Division has a Sundry Notice dated March 21, 2002, for ASU A #001 stating that you had retained Hughes Drilling and that the well would be plugged by April 2, 2002. The Division also has a Sundry Notice dated March 21, 2002, for Federal #001 stating that you had retained Hughes Drilling and that the well would be plugged by April 1, 2002. However, the Division does not have a report from you for either well showing that the plugging was completed. Please provide copies of the following by Monday, September 1, 2003: notices filed with the Division along with any supporting documentation showing that these two wells were actually plugged prior to May 14, 2003.
