STATEMENT OF THE CASE

OPPONENT:

Fasken is an operator in the Apache Ridge-Bone Springs Oil Pool and is opposed to Cimarex's application to increase the 40-acre spacing unit depth bracket oil allowable from 275 barrels of oil per day with a 2,000:1 GOR to 1300 bopd with a 3,000:1 GOR.

This increase of 4.75 times the current allowable, among other things, (a) will not increase ultimate recovery of hydrocarbons, (b) will allow Cimarex to recovery more than its share of recoverable hydrocarbons and (c) will drain reserves from the off-setting spacing units.

Fasken seeks the denial of this application.
