CHAIRMAN FESMIRE: At this time, we will call the Friday, November 7th, 2008, special meeting of the New Mexico Oil and Gas Conservation Commission to order.

Let the record reflect that Commissioners Bailey,
Olson, and Fesmire are all present and, therefore, there is a
quorum present, and the Commission is capable of transacting
business.

This is, again, a special meeting that was called to address two issues: The continuation of Case No. 14180 and Case No. 14074.

At this time, we will take up the first order of business on the docket, Case No. 14180. It is the Application of the Oil Conservation Commission for Repeal of Existing Rules 19.15.1 through 19.15.15 NMAC; adoption of new Rules 19.15.2 through 19.15.16 NMAC; 19.15.18 through 19.15.26 NMAC; 19.15.29 and 19.15.30 NMAC; 19.15.34 through 19.15.37 NMAC; and, 19.15.39 NMAC and amending 19.15.17 and 19.15.36 NMAC, to make conforming changes Statewide.

At this time, are there -- we'll take an entry of appearance for any attorney present for that case. Seeing none, we will continue. Have the Commissioners had the chance to examine the order and attachments presented by counsel in this case?

COMMISSIONER BAILEY: Yes, I have, and I commend the OCD for undertaking this massive work.

COMMISSIONER OLSON: I'll agree with Commissioner 1 2 This was something that was needed to kind of 3 reorganize and make things a little simpler for the average person to be able to follow through on the regulations. So I 4 5 commend the Division for all their work on this as well, especially the counsel on this for preparing all this. 6 7 CHAIRMAN FESMIRE: And the Chair agrees with the statement of both Commissioners, and at this time, would 8 9 entertain a motion to adopt the order as presented by counsel. 10 COMMISSIONER BAILEY: I so move. COMMISSIONER OLSON: Second. 11 12 CHAIRMAN FESMIRE: All those in favor of adopting the order as presented by counsel, signify by saying "aye." 13 14 COMMISSIONER BAILEY: Aye. 15 COMMISSIONER OLSON: Aye. 16 CHAIRMAN FESMIRE: Aye. Let the record reflect that 17 the order was unanimously adopted and will be signed and 18 transmitted to the secretary. The record should reflect that the order has been 19 20 signed by all three Commissioners and transmitted to the 21 secretary. 22 23 CHAIRMAN FESMIRE: The next order of business before 24 the Commission is Case No. 14074, the de novo Application of 2.5 the New Mexico Oil Conservation Division for a Compliance Order against Jackie Brewer, d/b/a Sandlott Energy. Would the attorneys present please enter their appearances?

MR. SWAZO: Sonny Swazo on behalf of the Oil Conservation Division.

MR. LARSON: Larry Larson of the Santa Fe office of Hinkle, Hensley, Shanor and Martin for Jackie Brewer, d/b/a Sandlott Energy.

CHAIRMAN FESMIRE: Mr. Swazo, I understand you have an announcement for the Commission.

MR. SWAZO: Yes. Thank you, Mr. Chair. We have entered into a stipulated order and settlement agreement in this case. The terms of the settlement order are that Mr. Brewer -- is that the operator remediate the pollution at the ten well sites that are the subject of this compliance action by May 7th, 2009.

We have entered into an agreement whereby operator will pay a \$12,000 penalty by November, I believe, 21st of 2008. He's also agreed to the imposition of \$48,000, which \$12,000 is part of this civil penalty. We have agreed, the OCD has agreed, to waive the \$36,000 portion of the \$48,000 civil penalty on the condition that the operator has these sites remediated by May 7th, 2008.

One thing that I would like to ask the Commission to do in this case is I'd like to have this case put on the Commission's -- on the first docket after the May 7th deadline

1 to see exactly where we stand in this case and to make sure 2 that the operator has properly remediated these sites. 3 Oh, yes, in the agreement, the operator has agreed to allow the OCD to plug and abandon these wells the forfeit the 4 5 applicable financial assurance if he does not meet the remediation deadline of May 7th, 2009. 6 7 CHAIRMAN FESMIRE: Mr. Swazo, that's Stipulation 18 8 in the order? Is that -- is it my understanding that the 9 Division and Mr. Brewer have agreed that no further action will be necessary to forfeit the \$50,000 if he does not comply with 10 11 the requirements in the order? 12 MR. SWAZO: Yes. 13 CHAIRMAN FESMIRE: Mr. Larson, is that your 14 understanding? 15 MR. LARSON: Yes, Mr. Chairman. 16 CHAIRMAN FESMIRE: Mr. Swazo, continue. I'm sorry I 17 interrupted you. 18 MR. SWAZO: I think that's it. I think I got 19 everything. 20 CHAIRMAN FESMIRE: Okay. Mr. Larson, did you have 21 anything to add? MR. LARSON: I agree with Mr. Swazo's 22 23 characterization of the terms of the order. 24 CHAIRMAN FESMIRE: And I notice that the agreed --25 that the settlement agreement has been signed by both Mr.

Brewer and Mr. Swazo, and that you're asking the Commission 1 2 today to ratify that agreement the make it part of the Commission record. 3 4 MR. LARSON: That's correct, Mr. Chairman. 5 CHAIRMAN FESMIRE: Have the Commissioners had a 6 chance to review the stipulated order and settlement agreement 7 in Case 14074? 8 COMMISSIONER BAILEY: Yes, I have, and I agree that 9 this is a reasonable solution. 10 CHAIRMAN FESMIRE: Commissioner Olson, have you had a 11 chance to review it? COMMISSIONER OLSON: Yes, I have, and I'll just say 12 13 that I'm glad that the parties were able to reach some 14 agreement in this matter and to resolve this without the 15 Commission having to take action on it. 16 CHAIRMAN FESMIRE: Counsel Bada, is there anything 17 that you need to add before the Commission today? 18 MS. BADA: No. Just a motion to adopt the stipulated 19 order. 20 MR. SWAZO: Mr. Chair, if I may interrupt for a 21 minute. I may have said 2008. I'd like to clarify the record. 22 It is May 7th, 2009. 23 CHAIRMAN FESMIRE: Mr. Swazo, does the order include
