Pending Orders:

- ACOI 77-A: Operator agreed to return all 16 wells to compliance by May 31, 2006, pay \$2,000 per well for each full month well remains out of compliance after that date.
- R-12767: Requires operator to return all 16 wells to compliance by October 2, 2007; authorizes OCD to plug wells and forfeit financial assurance if operator fails to meet deadline.
- R-12768-C: Requires operator to plug or transfer all wells by 12-31-08.
