The OCD has requested that the OCC accept the written testimony of Ms. Cheryl Bada in support of the application. Ms. Bada's written testimony was filed with the application. Ms. Bada will be present at the hearing to adopt under oath the prepared written testimony, subject to cross-examination and motions to strike.

After filing the application, the OCD discovered a number of typographical and grammatical errors in the proposed rules, together with some erroneous cross-references. On August 27, 2008 the OCD filed its proposed modifications to correct those errors. The OCD requests that it be allowed to prepare the final version of the rules for the Oil Conservation Commission's order in this case, making whatever changes the Commission decides to adopt. This will allow the OCD to prepare a version of the proposed rules that conforms to the formatting requirements of the New Mexico Administrative Code.
