

In the matter of the application of the Oil Conservation Division of the Energy and Minerals Department upon its own motion for an order for the creation of new pools in Chaves, Eddy, and Lea Counties, New Mexico, the abolishment of certain existing pools in Lea County, New Mexico, the extension of vertical limits and redesignation of an existing pool in Lea County, New Mexico, and the extension of certain existing pools in Chaves, Eddy and Lea Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to appear and show cause why such creations, abolishments, redesignations, and extensions should not be made.

(a) CREATE a new pool in Eddy County, New Mexico, classified as a gas pool for Wolfcamp production and designated as the South Big Sinks-Wolfcamp Gas Pool. The discovery well is the Perry R. Bass Poker Lake Unit No. 52 located in Unit C of Section 33, Township 25 South, Range 31 East, NMPM. Said pool would comprise:
