ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 a.m. on May 12, 1983, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 18th day of May, 1983, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Clements Energy, Inc., seeks to amend Orders Nos. R-7155 and R-7155-A to include pooling the Wolfcamp formation in the NE/4 of Section 14, Township 14 South, Range 34 East, NMPM, High Plains-Pennsylvanian Pool, Lea County, New Mexico.

(3) That the producing formation in the High Plains-Pennsylvanian Pool area may include both Wolfcamp and Pennsylvanian formations.

(4) That Orders Nos. R-7155 and R-7155-A should be amended to include the Wolfcamp formation.

IT IS THEREFORE ORDERED:

(1) That Findings No. (2) of Division Orders Nos. R-7155 and R-7155-A are changed to read in their entirety as follows:

"(2) That the applicant, Clements Energy, Inc., seeks an order pooling all mineral interests in the Wolfcamp and Pennsylvanian formations underlying the NE/4 of Section 14, Township 14 South, Range 34 East, NMPM, High Plains-Pennsylvanian Pool, Lea County, New Mexico."

(2) That the first paragraph of Order No. (1) of Division Order No. R-7155 is changed to read in its entirety as follows:

"(1) That all mineral interests, whatever they may be, in the Wolfcamp and Pennsylvanian formations underlying the NE/4 of Section 14, Township 14 South, Range 34 East, NMPM, High Plains-Pennsylvanian Pool, Lea County, New Mexico, are hereby pooled to form a standard 160-acre oil spacing and proration unit to be dedicated to a well to be drilled at a standard location thereon."

(3) That the remainder of said Orders Nos. R-7155 and R-7155-A are unchanged.

(4) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.

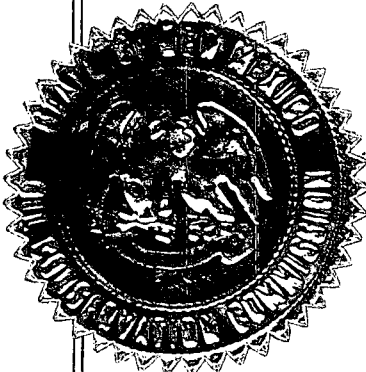
