

oped on statewide spacing rules, to include the NW/4 of  
Section 25, Township 16 South, Range 36 East, N.M.P.M.,  
and the formation of a standard 40 acre oil spacing and  
proration unit comprised of the SW/4NW/4 of Section 25, to  
be dedicated to the South Lovington 25 Well No. 1, located  
at an orthodox oil well location 1977 feet from the north line  
and 330 feet from the west line of Section 25. In the alter-  
native, applicant requests approval of a non-standard 40  
acre oil spacing and proration unit in the Northeast Lovin-  
gton-Upper Pennsylvanian Pool, which is spaced on 80  
acres under Order No. R-3816, comprised of the  
SW/4NW/4 of Section 25. The non-standard unit will be  
dedicated to the South Lovington 25 Well No. 1, located at  
an unorthodox oil well location in said pool, for which appli-  
cant also requests approval. The application is scheduled  
to be heard at 8:15 a.m. on Thursday, January 8, 2009 at  
the Division's offices at 1220 South St. Francis Drive, Santa  
Fe, New Mexico 87505. As an interest owner offsetting the  
well and/or well unit, you have the right to enter an appear-  
ance and participate in the case. Failure to appear will pre-
