

## STATEMENT OF CASE

### APPLICANT

Applicant seeks an order of the Oil Conservation Division force-pooling all unleased and uncommitted mineral interests and all uncommitted working interests in the Basin-Fruitland Coal Gas Pool underlying the N/2 of Section 18, Township 29 North, Range 13 West, N.M.P.M., San Juan County, New Mexico, forming a previously approved non-standard 250 acre spacing and proration unit to be dedicated to its Westland Park #1 Well and its Westland Park #2 Well to be drilled at standard gas well locations thereon in the NE/4 and NW/4, respectively.

Applicant also seeks to be designated as the operator of the wells and that it be authorized to recover the costs of drilling, completing, equipping and operating the wells, together with an additional charge for the risk associated with drilling and completing the wells at the maximum rate established by the Oil Conservation Division for wells of this kind and location.

Applicant further requests that it be allowed a reasonable charge for the supervision of the wells during the drilling and production stages.

This application has been filed because Applicant has been unable to obtain the voluntary joinder of numerous owners of unleased mineral interests and uncommitted working interests underlying, or applicable to, the lands within the proposed spacing and proration unit for the wells.


