STATEMENT OF THE CASE

APPLICANT

Applicant seeks an order allowing it to drill and operate its proposed Lucky Wolf "30" Fed. Com. Well No. 2, a horizontal well in the Wolfcamp formation in Lot 3, NE/4SW/4, and N/2SE/4 (the N/2S/2) of Section 30, Township 16 South, Range 28 East, NMPM. The NE/4SW/4 of Section 30 will be simultaneously dedicated to the proposed well, to be operated by applicant, and to the existing Crow Flats Fed. Com. Well No. 1, a vertical Wolfcamp well, located in the NE/4SW/4 of Section 30, operated by Three Span Oil & Gas, Inc.

Applicant will show that (i) Division rules allow more than one well on a well unit, (ii) Three Span Oil & Gas, Inc. does not have the right to drill another well in the NE/4SW/4 of Section 30,

(iii) a horizontal well is necessary to economically recover reserves and protect correlative rights, and (iv) Three Span Oil & Gas, Inc. will not be harmed by a second well on the well unit.




