Gary – I looked into the bonding situation for Mr. Langlitz. Dorothy Phillips received the financial assurance for the Saladar Unit #1 in this afternoon's mail. It has not yet been reviewed for approval.

Mr. Langlitz has additional bonding issues. He has a total of three fee wells that require financial assurances (one of them is the Saladar Unit #1). He posted single well bonds for the three wells some time ago. The amounts required for single well bonds went up January 1, 2008, so all three bonds need to be replaced with financial assurances in the correct amounts, not just the bond for the Saladar Unit #1. He has been out of compliance on the financial assurance issue for almost six months.

Saladar Unit #2 needs \$5690

Saladar Unit #11 needs \$5707

Although I would be willing to give Mr. Langlitz an extension of time to comply with ACO 225, I will need to have him post the additional financial assurances for the #2 and the #11, or demonstrate that he is in the process of doing so. Until he posts financial assurances in the correct amounts for those wells, he will be in violation, and Will Jones will not be able to approve the MIT tests.
