RESPONSE OF THE OIL CONSERVATION DIVISION TO ORDER NO. R-13096

Order No. R-13096, issued March 2, 2009, requires the Oil Conservation Division (OCD) to file a proposed real property description by section, township and range for that portion of the Galisteo Basin located within Santa Fe County. The OCD files the attached map and real property description in response to Order No. R-13096.

The two maps attached to this pleading were used to create the proposed real property description.

The smaller map was generated by the State Engineer's Office by applying the outline of the Galisteo Basin watershed to a map showing township boundaries. The Galisteo Basin watershed includes both surveyed areas and un-surveyed areas. If a surveyed section, or a portion of a surveyed section, falls within the outline of the Galisteo Basin, that section is indicated, and the appropriate range is shown for that section.

The other map is an enlarged version of the map generated by the State Engineer's Office, with the sections hand-numbered.

Proposed Real Property Description.

The proposed real property description describes all <u>surveyed</u> sections that appear on the map generated by the State Engineer's Office, no matter how small a portion of that section falls within the outline of the Galisteo Basin.

<u>Un-surveyed</u> areas within the Galisteo Basin are described by the surveyed sections that surround them. The surveyed sections are listed in the order they appear, moving clockwise around the un-surveyed area. In two places, the outline of the Galisteo Basin passes through unsurveyed areas. There, the description attempts to approximate the outline of the Galisteo Basin using surveyed sections as reference points.

The map generated by the State Engineer's Office shows the outline of the Galisteo Basin with more precision than the map used by the OCD in preparing the original legal description for the Galisteo Basin, and it includes surveyed sections even when only very small portions of those sections fall within the outline of the Galisteo Basin. In preparing this proposed real property description, the OCD included a surveyed section if State Engineer's Office map indicated that any part of that section, no matter how small, falls within the outline of the Galisteo Basin. Consequently, several sections appear in this proposed real property description that did not appear in the original description for San Miguel and Sandoval Counties. Those additional sections are typed in bold, and underlined, so the Commission can better compare the original and the revised descriptions.




