**APPLICATION**

BP AMERICA PRODUCTION COMPANY, ("BP") through its undersigned attorneys, hereby makes application to the Oil Conservation Division for an order amending Division Order No. R-10604 (Case No. 11532). Pursuant to the provisions of Division Rule 19.15.12.10 NMAC, BP seeks authorization to surface commingle Basin Fruitland Coal Pool production from its Sammons Gas Com F Well No. 1S (API No. 30-045-33104) located 175 feet from the South line and 695 feet from the West line of Section 7, Township 29 North, Range 9 West, NMPM, San Juan County with wells that were approved under Order No. R-10604 and in support of this application states:

1. BP is the operator of the Sammons Gas Com F Well No. 1S located 175 feet from the South line and 695 feet from the West line of Section 7, Township 29 North, Range 9 West, NMPM, San Juan County, New Mexico.

2. In Division Order No. R-10604, dated May 29, 1996, BP was authorized to surface commingle production from the Sammons Gas Com D Well No. 1 (API No. 30-045-21005) located 130 feet from the South line and 1425 feet from the West line; the Sammons Gas Com C Well No. 1 (API No. 30-045-08429) located 270 feet from the South line and 1450 feet from the West line; and the Sammons Gas Com B Well No. 1A (API No. 30-045- 25021) located 230 feet from the South line and 790 feet from the

West line, all in Section 7, Township 29 North, Range 9 West, NMPM, San Juan County, New Mexico.

3. Applicant now seeks to surface commingle the Sammons Gas Com F Well No. 1S in order to utilize the same production equipment, including compression, which would allow for the economic recovery of remaining gas reserves.

4. Applicant previously submitted Forms C-103 and C-107B to the Division, attached as Exhibit A. However, to amend Order No. R-10604, this application must go to hearing.

5. All interest owners in Exhibit B to this application were notified of the proposed commingling.

6. Approval of this application will result in efficient production storage and measurement operations for the subject well and is otherwise in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, BP America Production Company requests that this application be set for hearing before an Examiner of the Oil Conservation Division on May 14, 2009 and, after notice and hearing as required by law, that the application be approved.

**This sundry notice is filed to Amend Order R-10604.** The current order allows for the surface commingling of 3 wells and stipulates yearly testing of each well to determine production allocation.

**In January 2009 meters were added and therefore production from each of the 3 wells is metered individually prior to being commingled. BP America respectfully requests permission to add a 4<sup>th</sup> well - the Sammons GC F 1S (30-045-33104) to the surface commingle permit. (see attached schematic)**

The production from each well that needs a separator is separated prior to the allocation meter. Production from each well will be metered prior to being commingled. The commingled production is then sent through compression prior to entering the sales meter. The difference between what is measured prior to commingling & what is sold through the sales meter is the fuel usage. This fuel usage is allocated back to each well based on the well production.

The working interest, royalty & overriding royalty interest owners in the subject wells is diverse therefore all are being notified by copy of this form - certified return receipt on March 20th.
