

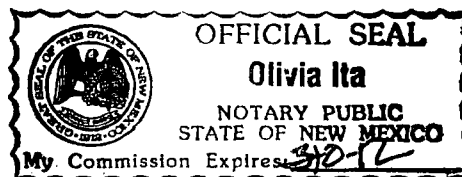

This application is set for hearing at 8:15 a.m. on June 1, 2009, at Porter Hall located in the Division's Santa Fe Office at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505.
