16	This matter came for hearing before the New Mexico Oil Conservation Commission on June 18, 2009, at the New
17	Mexico Energy, Minerals and Natural Resources Department, 1220 South St. Francis Drive, Room 102, Santa Fe, New Mexico.

- 1 CHAIRMAN FESMIRE: Let the record reflect that
- 2 this is the regular monthly meeting of the New Mexico Oil
- 3 Conservation Commission, that all three commissioners are
- 4 present.
- 5 It is June 18, 2009. Due to some unfortunate
- 6 occurrences, not the least important of which is one of
- 7 the attorneys falling down a flight of stairs, we're going
- 8 to delay convening the meeting until 11:00.
- 9 That also gives us a chance to make some
- 10 editorial changes that were brought up in the orders that
- 11 will be presented today.
- So at this time, we're going to adjourn and
- 13 continue the regularly scheduled meeting of the Commission
- 14 until 11:00 this morning back in this room.
- Is there anything else from the Commission?
- 16 COMMISSIONER BAILEY: No.
- 17 COMMISSIONER OLSON: No.
- 18 CHAIRMAN FESMIRE: So we'll reconvene at 11:00
- 19 here in the room.
- 20 (Note: The meeting adjourned and reconvened at
- approximately 12:15 p.m.)
- 22 CHAIRMAN FESMIRE: Let the record reflect that
- 23 this is a continuation of the regularly scheduled June
- 24 2009 New Mexico Oil Conservation Commission hearing.
- It's being held on June 18, 2009 in Porter Hall.

- 1 The record should also reflect that Commissioners Bailey,
- 2 Olson and Fesmire are all present.
- The first order of business today is the
- 4 adoption of the minutes of the May 27, 2009 Commission
- 5 meeting. Have the Commissioners had a chance to look at
- the minutes as presented by the secretary?
- 7 COMMISSIONER BAILEY: Yes, I have, and I move
- 8 that we adopt them.
- 9 CHAIRMAN FESMIRE: Is there a second?
- 10 COMMISSIONER OLSON: I'll second that. I have
- 11 reviewed them and I believe they accurately reflect our
- 12 actions taken at the meeting.
- 13 CHAIRMAN FESMIRE: All those in favor of
- 14 adopting the minutes as presented by the secretary signify
- 15 by saying aye.
- 16 COMMISSIONER BAILEY: Aye.
- 17 COMMISSIONER OLSON: Aye.
- 18 CHAIRMAN FESMIRE: Let the record reflect that
- 19 the minutes have been unanimously adopted by the
- 20 Commission, signed by the Chairman, and conveyed to the
- 21 secretary.
- The next cause before the Commission is Case
- No. 14292, the Application of the New Mexico Oil
- 24 Conservation Division for the Adoption of Amendments to
- 25 Rule 19.15.17, the "Pit" Rule, Statewide.

- 1 The Commission has previously taken testimony in
- 2 this case and has directed counsel to draft an order that
- 3 adopts and memorializes the Commission's decision in this
- 4 case.
- 5 Have the Commissioners had the opportunity to
- 6 review the order and the attachment to the order as
- 7 presented by counsel?
- 8 COMMISSIONER BAILEY: Yes, I have, and I move
- 9 that we adopt this Order.
- 10 COMMISSIONER OLSON: I've reviewed it as well
- and I believe it accurately reflects our deliberations
- 12 that were conducted.
- 13 CHAIRMAN FESMIRE: All those in favor of -- is
- 14 there a second to the motion?
- 15 COMMISSIONER OLSON: That's a second.
- 16 CHAIRMAN FESMIRE: Okay. All those in favor of
- adopting Order R, No. 12939A in Case No. 14292 signify by
- 18 saying aye.
- 19 COMMISSIONER BAILEY: Aye.
- 20 COMMISSIONER OLSON: Aye.
- 21 CHAIRMAN FESMIRE: Aye. Let the record reflect
- 22 that the order was unanimously adopted. It will be signed
- 23 by the members of the Commission and transmitted to the
- 24 secretary.
- The next order of business before the Commission

- 1 is Case No. 14255, Application of the New Mexico Oil
- 2 Conservation Division through it's Environmental Bureau
- 3 Chief for the adoption of an amendment to 19.15.39 NMAC
- 4 adding new sections to be codified at 19.15.39.9 and
- 5 19.15.39.10 NMAC addressing adding special provisions for
- 6 Santa Fe County in the Galisteo Basin, Santa Fe, Sandoval
- 7 and San Miquel Counties, New Mexico.
- 8 The Commission has previously taken testimony in
- 9 this case, has deliberated, and has instructed counsel to
- 10 draft an order that reflects those deliberations.
- 11 Have the commissioners had the opportunity to
- 13 review that order?
- [] COMMISSIONER OLSON: Yes, I have reviewed that
- order and I think it reflects the actions and
- 15 deliberations accurately that we had conducted. And I
- 16 move that we approve the order and the accompanying rule
- 17 changes.
- 18 CHAIRMAN FESMIRE: The Chair will second the
- 19 motion. Commissioner Bailey, I understand you might have
- 20 something you want to put on the record before we proceed?
- 21 COMMISSIONER BAILEY: As designee of the
- 22 Commissioner of Public Lands, I cannot sign this rule that
- 23 negatively impacts the supportive schools, prevents
- 24 development of the natural resources and revenues
- 25 generated for the beneficiary.

- 1 It revokes without supporting scientific
- 2 testimony certain OCD rules that were developed through
- 3 thoroughly reviewed technical presentations and careful
- 4 deliberations by the Commission.
- No unbiased technical testimony has shown
- 6 deficiencies in current statewide rules or any
- 7 contamination cases in the Galisteo Basin or Santa Fe
- 8 County arising from operations conducted under current
- 9 rules.
- I therefore, as representative of the State Land
- 11 Office, object to the passage of this rule and I cannot
- 12 sign this order.
- 13 CHAIRMAN FESMIRE: There is a motion before the
- 14 Commission to adopt the rule. It's been seconded by the
- 15 Chair. All those in favor signify by saying aye. Aye.
- 16 COMMISSIONER OLSON: Aye.
- 17 CHAIRMAN FESMIRE: Let the record reflect that
- 18 the motion to adopt the rule was passed by a vote of two
- 19 to one with Commissioners Fesmire and Olson voting in the
- 20 affirmative. The order will be signed by Commissioners
- 21 Fesmire and Olson and transmitted to the secretary.
- The next issue before the Commission is the
- 23 presentation of Proposed Findings of Fact and Conclusions
- of Law in Case No. (13957) the Amended Application of
- 25 Energen Resources Corporation to Amend the Cost Recovery

- 1 Provisions of Compulsory Order No. R-1960, to Determine
- 2 Reasonable Costs and for Authorization to Recover Costs
- 3 from Production of Pooled Mineral Interests, Rio Arriba
- 4 County, New Mexico.
- 5 Counsel Smith, I understand that there have been
- 6 some requests in this case?
- 7 MR. SMITH: Yes. I had a phone call from Scott
- 8 Hall, the attorney for Energen, who indicated to me that
- 9 because he had been out of town a great deal, that he
- 10 would be unable to meet the June 18th deadline.
- He indicated to me that he would submit a letter
- or a motion, whichever would be appropriate, to the
- 13 Commission, and that he would seek approval of opposing
- 14 counsel.
- 15 CHAIRMAN FESMIRE: Has that been done, do you
- 16 know?
- 17 MR. SMITH: I have not heard anything from
- 18 either of them since then. I note, however, that opposing
- 19 Counsel, James Bruce, is not here, so --
- 20 CHAIRMAN FESMIRE: Well, Mr. Bruce has submitted
- 21 at the beginning of the commission hearing this morning
- 22 his Proposed Findings and Conclusions.
- MR. SMITH: Okay.
- 24 CHAIRMAN FESMIRE: Did Mr. Hall say when he
- 25 could get his pleadings to us.

- 1 MR. SMITH: No, he didn't. I know he was out of
- 2 town when he spoke with me and I thought he was going to
- 3 get that ironed out with opposing counsel. I certainly
- 4 can get hold of his secretary or him sometime today to try
- 5 to find that out.
- 6 CHAIRMAN FESMIRE: What's the will of the
- 7 Commission concerning this? It was sort of a unilateral
- 8 decision on the way to a trip to Hawaii, I understand.
- 9 COMMISSIONER BAILEY: To allow another timetable
- 10 for their submittal.
- 11 MR. SMITH: I think that's certainly what
- 12 Mr. Hall wanted.
- 13 CHAIRMAN FESMIRE: Did he indicate how long it
- 14 would take him?
- 15 MR. SMITH: No, he did not. I made no inquiry
- 16 of these things because my impression was that he was
- 17 going to take this to the Commission because I don't have
- 18 the authority to okay that kind of thing.
- 19 CHAIRMAN FESMIRE: Madam Secretary, have you
- 20 heard from him?
- MS. DAVIDSON: I have not heard from him.
- 22 CHAIRMAN FESMIRE: Would the Commission be
- 23 adverse to giving Mr. Hall another week? For the first
- 24 time, Mr. Bruce is on time and everybody else is late.
- 25 COMMISSIONER OLSON: I guess my only concern is

- 1 whether Mr. Bruce objects to it or not, I don't know.
- MR. SMITH: Do you want me to go call Mr. Bruce
- 3 while you guys are conducting other business? It's 12:30.
- 4 He's probably out suntanning.
- 5 CHAIRMAN FESMIRE: I hope he doesn't read this
- 6 transcript. We were planning on acting on this at the
- 7 July 16th meeting.
- 8 MR. SMITH: That's right.
- 9 CHAIRMAN FESMIRE: How long would it take you to
- 10 draft a -- comfortably to draft an order in this case?
- MR. SMITH: Well, I'm out of town the first week
- of July and the last couple of days of this month, so that
- 13 will cut me back to about three weeks.
- I should be able to do it, but on the other
- 15 hand, I don't really want to cramp the Commission in their
- 16 ability to review this.
- I can get it ready but it will cramp the
- 18 Commission in its review, I think. So in my view, it's
- 19 really up to the Commission.
- 20 CHAIRMAN FESMIRE: If we go another week, that
- 21 puts us to the 25th. That's about the time you leave
- 22 town, right?
- 23 MR. SMITH: That is the time I leave town.
- 24 COMMISSIONER OLSON: Just make it when he comes
- 25 back.

- 1 CHAIRMAN FESMIRE: Why don't you contact
- 2 Mr. Hall? Is that okay with you?
- 3 COMMISSIONER BAILEY: Sure.
- 4 CHAIRMAN FESMIRE: And give him until you get
- 5 back to complete it.
- 6 MR. SMITH: Okay.
- 7 CHAIRMAN FESMIRE: And if he does not make it to
- 8 the Commission by that time, I think you can draft the
- 9 Proposed Findings without his assistance and we'll lean
- 10 very heavily on what Mr. Bruce has provided.
- MR. SMITH: Okay. And you would like to enter
- 12 the order --
- 13 CHAIRMAN FESMIRE: On the 16th of July.
- MR. SMITH: On the 16th of July.
- 15 CHAIRMAN FESMIRE: Is that going to be too short
- 16 a time period for you?
- MR. SMITH: No, not if you guys can turn it
- 18 around, I'll get it to do, you bet.
- 19 CHAIRMAN FESMIRE: Well, with that, we will
- 20 continue Case No. 13957 and extend the deadline for
- 21 submission of Proposed Findings of Facts and Conclusions
- 22 to Counsel Smith until the day he returns, which is?
- MR. SMITH: I'd love to tell you that. Is the
- 24 4th on a Saturday? I believe it will be the 6th.
- 25 CHAIRMAN FESMIRE: The 6th?

- 1 MR. SMITH: Yes.
- 2 CHAIRMAN FESMIRE: And you might also contact
- 3 Mr. Bruce and give him until then to modify or change his
- 4 Proposed Findings and Conclusions so that he has the same
- 5 amount of time as Mr. Hall.
- 6 MR. SMITH: Okay.
- 7 CHAIRMAN FESMIRE: The next item before the
- 8 Commission is Case No. 14055, the Application of the New
- 9 Mexico Oil Conservation Division for a Compliance Order
- 10 Against C&D Management Company doing business as Freedom
- 11 Ventures.
- I believe at the request of counsel, this case
- will be continued to the July 16, 2009 Commission meeting.
- 14 Is that correct, Secretary?
- MS. DAVIDSON: That's correct.
- 16 CHAIRMAN FESMIRE: The next case before the
- 17 Commission is actually two related cases, Case No. 14149,
- 18 the Application of the El Paso Exploration and Production
- 19 Company, L.P. to Abolish the Van Bremmer Canyon-Vermejo
- 20 Gas Pool, Expand the Castle Rock Park-Vermejo Gas Pool,
- 21 and to Establish Special Rules and Regulations for the
- 22 Castle Rock Park-Vermejo Gas Pool in Colfax County, New
- 23 Mexico.
- The related case is Case No. 14150. It's the
- 25 Application of El Paso Exploration and Production Company,

- 1 L.P. to Expand the Stubblefield Canyon Raton-Vermejo Gas
- 2 Pool, and to Establish Special Rules and Regulations for
- 3 the Pool in Colfax County, New Mexico.
- At the request of counsel, these cases will also
- 5 be continued to the July 16th docket.
- And the last case before the Commission today is
- 7 Case No. 14166, the Application of Fasken Oil and Ranch,
- 8 Limited for an Order Authorizing the Drilling of an
- 9 Additional Well at an Unorthodox Location in the "Potash
- 10 Area," Lea County, New Mexico.
- This case will be continued. Secretary, as of
- 12 right now, we have not heard back from --
- MS. DAVIDSON: That's right.
- 14 CHAIRMAN FESMIRE: This case will be continued
- 15 to July 27th on a special docket and be heard on that day.
- Any other business before the Commission?
- 17 COMMISSIONER BAILEY: No.
- 18 COMMISSIONER OLSON: No.
- 19 CHAIRMAN FESMIRE: Okay. With that, the Chair
- 20 would entertain a motion to adjourn.
- 21 COMMISSIONER BAILEY: I so move.
- 22 COMMISSIONER OLSON: Second.
- 23 CHAIRMAN FESMIRE: Let the record reflect that
- 24 the motion has been made. All those in favor signify by
- 25 saying aye.
