1 MR. BROOKS: At this time, we will call Case
2 No. 14157, Application of Forest Oil Corp. for Approval of a
3 Secondary Recovery Project, Eddy County, New Mexico.

4 And I gather this was continued from August the 7th
5 to supplement the record; is that correct?

6 MR. BRUCE: That's correct, Mr. Examiner. If I may,
7 Mr. Examiner, this case was -- I should say Jim Bruce,
8 representing the applicant.

9 This case was heard two weeks ago, and the testimony
10 was submitted. There was one question, I think it was,
11 Mr. Jones had regarding this case -- two questions similar.

12 This case involves the SE/4 of Section 16 which
13 Forest refers to as its State B lease, which is where the
14 secondary recovery project is requested. There was one
15 question which was what is the ownership of the State B lease.
16 Obviously it's a State lease, and Forest Oil owns 100 percent
17 of the working interest.

18 I've submitted this affidavit to you marked
19 Exhibit 11 from the landman at Forest Oil. In paragraph 4, he
20 states that working interest ownership in the State B lease
21 from the surface to the base of the San Andres formation which
22 includes the injection zone, the Grayburg Jackson pool, is
23 100 percent owned by Forest Oil Corporation.

24 The second question -- it also came up during the
25 examination that the offsetting Skelly unit has an ongoing

1 waterflood, and the two projects are kind of related. A
2 question was also raised as the ownership in the working
3 interest in the Skelly unit. And that's addressed in the
4 paragraph 5 of this affidavit. If you look at Attachment A to
5 Exhibit 11, there is a land plat of the Skelly unit. It's a
6 100 percent federal unit which offsets the SE/4 of Section 16,
7 as you can see. It's all federal leases. And all of the
8 acreage except 120 acres is in a participating area for the
9 Grayburg Jackson pool.

10 And in so as far as depths from surface to 5,000
11 feet, Forest Oil Corporation owns 100 percent of the working
12 interest. That addresses Mr. Jones second question.

13 And just for historical purposes, I think we had some
14 discussion about the Skelly unit. I've attached the -- the
15 first page didn't copy well, but the unit agreement for the
16 Skelly unit which was formed in 1937 -- probably one of the
17 first units formed in the State of New Mexico -- the earliest
18 units approval I could see from the Division was in 1950 for
19 unit agreements -- and this unit was formed in 1937.

20 As I noted on the record last time, it's a voluntary
21 unit. The unit was formed for exploration and it later --
22 later a waterflood was instituted in the unit. And I think the
23 waterflood expansion orders are referenced in the prior
24 testimony.

25 So with that, I submit Exhibit 11. The landman is

1 not here. He is available to testify by telephone, if
2 necessary.

3 MR. BROOKS: Very good. Well, I don't recall the
4 hearing well enough to remember exactly what Mr. Jones'
5 questions were, and he's not here today. So you have tendered
6 Exhibit No. 11?

7 MR. BRUCE: Yes, and I move the admission of
8 Exhibit 11.

9 MR. BROOKS: Exhibit 11 will be admitted.

10 [Applicant's Exhibit 11 admitted into evidence.]

11 MR. BROOKS: Case No. 14157 will be taken under
12 advisement.


