Applicant seeks an order establishing special rules and regulations for the Apache Ridge-Bone Spring Pool, including a special depth bracket allowable of 1300 barrels of oil per day and a limiting gas:oil ratio of 3000 cubic feet of gas for each barrel of oil produced, effective as of August 1, 2007. The pool covers parts of Section 36, Township 19 South, Range 33 East, N.M.P.M., and Sections 30-32, Township 19 South, Range 34 East, N.M.P.M. The pool is centered approximately 19-1/2 miles west of Monument, New Mexico. Application of Fasken Oil and Ranch, Ltd. for Compliance order requiring Cimarex Energy Co. of Colorado to comply with the Division's oil proration rules for the Apache Ridge-Bone Spring Pool, Lea County, New Mexico. Applicant seeks relief of current over production of the depth bracket allowable by immediate shut-in of the Cimarex operated wells over produced in the Apache Ridge-Bone Springs Oil Pool. Further, Applicant requests the shut-in period be determined by the cumulative over produced oil volume divided by the most recent month daily oil rate or the current depth bracket allowable, whichever is lesser for the following wellbores:
