

Dear Paul,

In accordance with my e-mail last week, this letter (faxed, then mailed) is to advise that Edge Petroleum Exploration Company (“Edge”) is not in a position to act upon your request for a Term Assignment *at this time*. As you are aware, Edge recently closed its data room and has since been in negotiations with numerous companies in regard to its assets and is hesitant to commit any interests that were reviewed by and that may be or become subject to commitment. I assure you that I do not – and will not – know anything in that regard until after the fact!

Having said that, and as we had discussed on Mewbourne’s Bradley “31” Fed Com #3 well in which we did at the last moment, grant you a Term Assignment under these same restrictive circumstances, Edge would most likely not wish its interest to be force pooled, but understands that you may need to move forward with your applications and plans. I can only apologize for this situation and trust you can understand why we need to practice this cautious policy.

If Edge has not formally announced a commitment of assets in the captioned area within 10 days or so of your filing for forced pooling, I would respectfully request that your offer/request remain open to Edge and to any possible successor-in-interest so as to allow re-consideration of your request prior to any force pooling hearing and hopefully save you the time and expense of filing.

Allow me to suggest that we both keep in contact about every 10 days so that if Edge’s assets in the captioned become available for assignment by Edge - or become subject to a sale, merger or other transaction which would require coordination involving any possible successor in interest timely – we can respond appropriately.



Hello, Paul ----

I'm not trying to be dense here (although maybe I am anyway and always will be), but one file I have shows Edge with ownership in Section 29 to all depths in the NW/4SW/4, in addition to the other files showing our ownership in the SW/4SW/4 and SE/4SW/4. The NW/4SW/4 would fall within the 320 spaced pooling for the S/2. I was asking if Edge was credited in the DOTO with an (Bone Springs to Morrow formation) interest in this NESW 40 acre interest for a 320 spacing or if the DOTO shows us only with shallow or no rights.

Also, I assumed, and so advised management, that since we did not grant a T/A before 5pm on July 1, 2009 (as set forth in your proposal dated 6/16/2009 which was received here on 6/22/2009), your request for a T/A was withdrawn and void as of that date, leaving us only the options to participate, be forced pooled or F/O to a 3rd party.

At that point I did not pursue resolving your request for an 80% NRI lease vs our ownership being only a 75% NRI to start with.

I agree that we have no WI in the SE/4 at this time, so that only leaves the question if your T/O credits us with an interest to the Morrow in the NW/4SW/4 --- or if my lease file is "corrupted" in computereze.

Hi, Paul ---

I'll send you a formal letter if needed to confirm this if should it occur, but right now it looks like we are going to have to allow you folks to force pool our interest in the well. I wanted you to have sufficient notice.

If so, I do have one remaining question -- in calculating payout --- we (Edge) only owns in the deep rights. If you dually complete the well, either 2 or 3 morrow-strawn-atoka formations - or both a shallow and deep right completion(s), how would you allocate the payout? If there are shallow right ONLY participants, how do you allocate drilling costs between those folks and parties who own in both shallow and deep rights? I'd assume all shallow right participants pay proportionately down to the depths they own, with deep right owners only bearing all deeper costs proportionately amongst themselves.

I've presented this scenario to numerous people, and told them in the event of separate completions in, say, the atoka and the morrow, each zone would have payout calculated separately. Likewsie as to any shallow zone as to drilling costs (but not completion costs). Since we have our fair share of contractors in accounting, I'm just trying to plan ahead so that I can adequately explain this to them.

Anyway, barring some overnight changes, you will need to move forward to have our interest force pooled. Thanks.

Bill , payout as to Edge's interest would only be calculated as to completions in formations spaced on 320 acres as in the Morrow, Atoka and Strawn formations. Payout calculations as to Edge's interest would not include any completion costs in the shallow formations as Edge has no interest in those formations which formations would include the Bone Spring and formations above the Bone Spring. MOC's JOA for the Bradley

"29" Fed. Com #1 will cover formations below the base of the Bone Spring formation. Sorry ya'll still can't make a trade.

On another note , MOC is interested in drilling horizontal Bone Spring tests in Sec. 11 and 12 , T19S, R29E,

Eddy Co. Edge has some interest in those Sections whereby you will soon be getting a proposal from us with AFE. It is my understanding that Cimarex Energy has already sent out farmout requests as advised by Chisos, Ltd. and Pure Energy. Hi, Paul -

You and I both - wish we could do SOMETHING. Keep in mind I am currently a Contractor here in the Land department, so anything I personally say as to committing Edge's interest is not under any official guise -- as an employee may be capable of committing Edge.....

As you may know, every month for 9 months, Edge's "balloon note" has been extended for one month as we have been able to make the huge interest payments -- and people are looking at the company - but it can't go on too much longer, I'd expect. So as to any trades on our shallow interests -- it's on a day-to-day basis. We do not know what will happen on a day-to-day basis and especially at the end of the month.

NO ONE has told me anything as to what is happening in negotiations (if any), not that I could say anything if they did anyway - so I don't know the company's status (don't WANT to know, actually) but my concern is if we grant a T/A, or a F/O -- and then a bankruptcy were filed, would that be a voidable contract? If Edge agreed to participate, could that agreement be voidable? If we had given a T/A, I think naming us in a force pooling would STILL be a good practical idea as I think the "interests" in the lands, as much as the parties owning them, may be claimed to be pooled, notice is out there and you'd have a good argument that if a T/A were voided, you'd be covered. By a forced pooling, Edge makes no election so I'd argue the pooling is not voidable - that, of course, is a bankruptcy issue.

I suspect if a sudden sale were to occur, an acquiring company might decide to participate or grant a T/A in a well on very short notice. Most likely, any negotiations PROBABLY have some agreement providing that we won't commit any viable interests unless we have to in order to preserve ownership, etc.

And it makes us look non-cooperative at times. Our hands may be tied. Glad that you understand that.

On the current deal at hand, the first time I read the pooling order, I didn't catch the 40-80-160 pools only applied to the borehole location - needless to say, I was envisioning the possible JOA to spread all those various interests and wondering how I'd explain it all!

From this side, I have to get high management to agree (in writing) that it is ok that we have decided to become force pooled. I do expect that to be done, so I think you can proceed in that regard as to Edge's interest, and I'll formalize this as soon as I can. Thanks..... as you can imagine -- an e-mail this long has 14 interruptions, so I hope it is coherent enough!

Bill , I too think force pooling is the answer and I think if we were to take a TA it could be subject to being voided if Edge were to go in bankruptcy. As to the properties in Sec. 11 and 12, I suspect that those lands are subject to JOAs whereby Edge would have a participation election to make. Also , right now we couldn't acquire a TA from Edge as Edge's interests are subject to several mortgages which we'd have to get Releases for or Subordinations. Pooling would solve the problem. Let me know if anything changes regarding Edge's status.
I'll get back with you soon regarding the Sec. 11 and 12 properties. Thanks Bill and have a great week.
