**STATEMENT OF CASE**

Applicant filed a form C-108 with the Division seeking administrative approval to convert its existing MWJ State #1Y (API 30-015-23888) oil well to a commercial salt water disposal well. Said well is located on State Trust Lands 860 feet from the South line and 2020 feet from the West line of Unit N, Section 30, Township 24 South, Range 29 East, NMPM, Eddy

County, New Mexico. Applicants seeks to inject up to 4000 barrels of produced water per day at a maximum pressure of 726 psi into the Delaware formations through perforations from 3630 to 4975 feet.

Scott Branson, the holder of a grazing lessee for this state acreage, filed an objection with the Division causing this matter to be set for hearing. See Attachment 1. The State Land Office, the owner of both the surface and mineral estate, does not have any objection to the proposed injection well. See Attachment 2.




