APPLICANT

Cimarex Energy Co. seeks an order approving a non-standard oil spacing and proration unit (project area) in the Abo/Wolfcamp formation comprised of Lot 4, SE/4SW/4, and S/2SE/4 (the S/2S/2) of Section 18, Township 15 South, Range 31 East, NMPM, to form a non-standard 159.29-acre oil spacing and proration unit (project area), and pooling all mineral interests in the Abo/Wolfcamp formation underlying the non-standard unit.
