These C-115s were returned by the OCD for either of two reasons:

Some had errors. When C & D resolved the error they created and submitted a new C-115 rather than adjusting the C-115 that was initially submitted.

A C-115 for the same reporting month had already been approved on the same day. Our system only accepts one C-115 per operator per reporting month per day so at duplicates are not sent to other systems during the evening updates. We return the non-approved C-115 to the operator requesting that they re-submit it if it contains more current information than was on the C-115 we accepted.
