STATEMENT OF THE CASE

APPLICANT

Applicant seeks an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the following acreage in Section 28, Township 21 South, Range 35 East, NMPM, and in the following manner: The N $\frac{1}{2}$ to form a standard 320 acre gas spacing and proration unit for any and all formations and/or pools developed on 320 acre spacing within that vertical extent; the NW $\frac{1}{4}$ to form a standard 160 acre gas spacing and proration unit for any and all formations and/or pools developed on 160 acre spacing within that vertical extent; and the NW $\frac{1}{4}$ NW $\frac{1}{4}$ to form a standard 40 acre oil spacing and proration unit for any and all formations and/or pools developed on 40 acre spacing within that vertical extent. The units will be dedicated to applicant's Longhorn "28" State Well No. 1, to be drilled at an orthodox location in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ (Unit D) of Section 28. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating

costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.


