Mewbourne Oil Company ("Mewbourne") as Operator proposes to form the captioned working interest unit ("WIU") to comprise the captioned land containing 1520.32 acres, more or less covering depths from the surface to the top of the Bone Spring Lime. The primary target formation for the proposed unit is the Yeso formation. The initial unit well will be drilled at a standard location in the NE/4SW/4 (Unit K) of the captioned Section 17 which well will be drilled to a depth sufficient to adequately evaluate the Yeso formation, estimated total depth being approximately 3,500 feet subsurface. Enclosed for Devon's signature is our AFE dated December 17, 2009 regarding Devon's unit ownership interest.

According to public records, EHW, L.L.C. owns a 7.291667% unleased mineral interest of 80 net acres in the N/2 of the captioned Section 18 which corresponds to approximately a 0.383692% unit working interest.

In the event you elect not to participate in the proposed WIU, Mewbourne offers to purchase a three (3) year paid up Oil and Gas Lease on the basis of \$250 per net acre providing a 3/16th royalty interest. At the end of the primary term, Mewbourne would be agreeable to 180 day continuous development whereby Mewbourne would release rights 100 feet below the total depth drilled on the leased premises and all proration units not dedicated to production upon cessation of the continuous development period.


