AFFIDAVIT OF KEVIN CARTWRIGHT

- I, Kevin Cartwright, being first duly sworn on oath, states as follows:
- 1. My name is Kevin Cartwright. I reside in Midland, Texas. I am the Landman employed by Mewbourne Oil Company ("Mewbourne") who is familiar with the status of the lands in Section 18, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico. I am a Petroleum Landman with over 4 years experience in the Permian Basin. I received my Bachelor of Business Administration degree from Texas Christian University in 2005.
- 2. Mewbourne seeks an order pooling all mineral interests from the surface to the top of the Bone Spring formation in all formations and pools in the SE/4 NW/4 of Section 18, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico.
- 3. Mewbourne owns working interest in the SE/4 NW/4 of Section 18 and has dedicated this proposed spacing unit to its Wyatt Draw "18" F Well No. 1. to be drilled as a wildcat oil well at a standard location 1650 feet from the North and West Lines (Unit F) of said Section 18 to a depth sufficient to evaluate all formations and pools to the top of the Bone Spring Lime. The top of the Bone Spring Lime is identified at a depth of 4,170 feet beneath the surface in the Density Neutron Electric Log run in the Nearburg Exploration Company Fairchild "24" Well No. 1 located 2100 feet from the North Line and 900 feet from the West Line of Section 24, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico. Attachment A is a plat of the subject lands showing the proposed spacing unit and the well location.
- 4. Attachment B lists the nature and percentage of the ownership interests in the subject spacing units.
- 5. This application has been instituted solely to pool the interests of working interest owners who do not oppose the application.

- 6. Mewbourne has made a good faith effort to gain the voluntary participation of each working interest owner identified on **Attachment B**.
 - A. The well was proposed January 28, 2010 with AFE enclosed. See Summary of Communications regarding Mewbourne's efforts to contact and obtain voluntary participation or obtaining Oil and Gas Leases in lieu of working interest owner's participation in the proposed well.
 - B. A copy of the well proposal letter and relevant correspondence is included as **Attachment C.**
- 7. Mewbourne requests that all interest owners in these spacing units be pooled and Mewbourne be designated operator of the wells and the spacing units.
- 8. Mewbourne proposes overhead charges (combined fixed rates) of \$ 4,000 per month while drilling and \$400 per month while producing.
- 9. Attachment D is a copy of the authorization for expenditure (AFE) for the well which estimates costs to casing point to be \$338,900 and a completed cost of \$622,500.
 - 10. Mewbourne plans to drill the Wyatt Draw "18" F Well No. 1 by April 1, 2010.
- 11. Attachment E are copies of the notice letters sent to those interest owners which Mewbourne seeks to pool and an affidavit of publication pursuant to Division rules.
- 12. Approval of this application will avoid the drilling of unnecessary wells, will prevent waste, will protect correlative rights, and allow Mewbourne and the other interest owners in the SE/4 NW/4 of Section 18 an opportunity to obtain their just and fair share of the oil and gas under the subject lands.


