In accordance with Section 10 of the Big Eddy Unit Agreement dated April 10, 1952, BOPCO, L.P., Operator of the referenced unit, hereby submits a Plan of Development for the Big Eddy Unit for the year 2010.

**HISTORY OF PAST DEVELOPMENT**

We refer to our previous Plans of Development for a detailed description of the operations conducted in this Unit in prior years.

**2009 ACTIVITY**

Big Eddy Unit Well No. 190, Eddy County, New Mexico – This well was drilled at a legal location being 990' FNL & 860' FWL Section 9, T22S-R28E, Eddy County, New Mexico. This well was completed in the Morrow Formation.

Indian Draw Deep 7 Com No. 3 Well, Eddy County, New Mexico – This well was drilled at a legal location being 740' FNL & 660' FEL, Section 7, T22S-R28E, Eddy County, New Mexico. This well was completed in the Morrow Formation.

**2008 PLUGGED AND ABANDONED**

Big Eddy Unit Well No. 71, Eddy County, New Mexico - Section 7, T22S, R29E, plugged and abandoned December 10, 2008

Big Eddy Unit Well No. 83, Eddy County, New Mexico - Section 10, T21S, R28E, plugged and abandoned December 14, 2008.

PARTICIPATING AREAS

Bass Enterprises Production Co. has submitted all wells drilled to date where adequate information is available for commercial determination and participating areas. In the event you have not received commercial determinations for the wells that have been drilled and completed and are currently producing, please advise at your earliest convenience and we will submit same to you.

FUTURE DEVELOPMENT

No Big Eddy Unit Wells will be drilled in 2010.

OFFSET OBLIGATIONS

Appropriate and adequate measures will be taken to prevent drainage of unitized substances from lands within the Big Eddy Unit area, or pursuant to applicable regulations.

MODIFICATIONS


In accordance with the terms and provisions of the Big Eddy Unit Agreement, this Plan of Development may be modified from time to time as a result of changing conditions.

EFFECTIVE DATE

This Plan of Development became effective January 1, 2010.
