2 before the Commission is Case Number 14326, the De Novo
3 Application of the New Mexico Oil Conservation Division for
4 a Compliance Order against Nacogdoches Oil and Gas. The
5 Applicant seeks an Order finding that the Operator
6 Nacogdoches Oil and Gas is in violation of the OCD Rule
7 19.15.8.9 as to 39 wells and Rule 19.15.25.8 as to 121
8 wells, requiring Nacogdoches Oil to bring all such wells
9 into full compliance with OCD rules by a date certain. The
10 Division further seeks authority to forfeit any associated
11 financial assurances, and to plug and abandon the subject
12 wells should the Operator fail to meet the deadline
13 established by the Order. This case has been continued to
14 the February 11, 2010 commissioner meeting.
