3 Application of the New Mexico Oil Conversation Division for
4 a Compliance Order against Nacogdoches Oil and Gas, Inc.
5 The applicant seeks an order finding that Operator NOG is in
6 violation of OCD Rule 19.15.8.9 as to 39 wells and Rule
7 19.15.25.8 as to 121 wells, requiring NOG to bring all such
8 wells into full compliance with OCD rules by a date certain.
9 The division further seeks authority to forfeit any
10 associated financial assurances, and to plug and abandon the
11 subject wells should the operator fail to meet the deadline
12 established by the order. This case also will be continued
13 to the December 16, 2009 Commission meeting.

16 motion to adjourn.


