The Oil Conservation Division (OCD) entered its appearance in Case No. 14353 to notify the hearing examiners that Chi Operating, Inc. (Chi) was out of compliance with 19.15.5.9 NMAC (Part 5.9). The matter was originally heard some time last summer. At that time, the OCD presented evidence that Chi was out of compliance with Part 5.9 based on its violation of the inactive well rule and financial assurance requirements. The matter has been continued many times, to give Chi time to return to compliance. The case is currently scheduled to be heard on the March 4, 2010 docket.

I am writing to inform you that according to OCD records, Chi is currently <u>in</u> compliance with Part 5.9 as to inactive wells and financial assurances.

Inactive wells:
