



This letter is to advise you that ConocoPhillips Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking an order amending Division Order No. R-2403, as amended, to increase the injection pressure limitations in the Maljamar Cooperative Agreement Unit Area located in portions of Sections 14 to 23 and 25 to 35 of Township 17 South, Range 32 East and portions of Section 30 of Township 17 South, Range 33 East, N.M.P.M., Lea County, New Mexico.

This application has been set for hearing before a Division Examiner at 8:15 AM on February 4, 2010. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

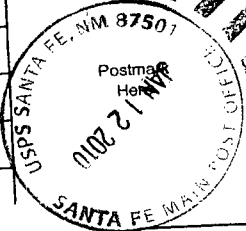

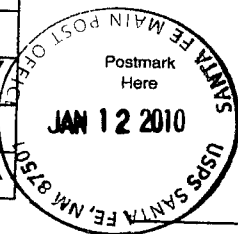
