- I, Richard Harris, being first duly sworn on oath, states as follows:
- 1. My name is Richard Harris. I reside in Centennial, Colorado. I am the Landman employed by McElvain Oil & Gas Properties, Inc. ("McElvain") who is familiar with the status of the lands in Section 3, Township 29 North, Range 13 West, NMPM, San Juan County, New Mexico.
- 2. McElvain seeks an order pooling certain interest owners in the S/2 of Section 3 from the surface to the base of the Pictured Cliffs formation, to form a 320-acre spacing unit (S/2) for the Fruitland Coal formation and a 160-acre spacing unit (SE/4) for the Pictured Cliffs formation.
- 3. McElvain owns a working interest in the S/2 of Section 3 and has dedicated the proposed spacing units to its Ruby Well No. 2 (API 30-045-34986) to be dual-completed at a non-standard location in the SE/4 of said Section 3 to a depth of approximately 1,465 feet. Attachments A and B are plats of the subject lands showing the proposed spacing units of each formation and the well location.
- 4. The proposed spacing units consist of fee leases. Attachments C and D list the nature and percentage of the ownership interests in the subject spacing units.
- 5. This application has been instituted solely to pool the interests of working interest owners who do not oppose the application or who can not be found.
- 6. McElvain has conducted a diligent search to locate and make a good faith effort to reach voluntary agreement with the parties listed on Attachments C and D:
  - a. McElvain has been attempting to lease the individual lot owners

since 2006. McElvain was able to lease or purchase the minerals of numerous lot owners in the S/2 of Section 3. The owners highlighted on Attachments C and D either cannot be found or have not agreed to lease, sell, or participate with their mineral interest.

- b. In an attempt to locate the individuals who cannot be found on Attachments C and D, McElvain has used various internet sites, searched the county records, and used the Accurint people search database by Lexis/Nexis.
- c. The Mineral Owners that McElvain has located but has been unable to reach agreement with have had numerous offers to either lease or sell their minerals to McElvain since 2006. McElvain has made a good faith effort to gain the voluntary participation of the locatable Mineral Owners listed on Attachments C and D. The Mineral Owners have been notified of McElvain's plans on multiple occasions including being compulsory pooled for McElvain's Ruby #1 well. McElvain will continue to pursue either leasing or purchasing these minerals.
- 7. McElvain requests that the parties listed on Attachment C and D who have not reached a voluntary agreement with McElvain be pooled and McElvain be designated operator of the well and the project area.
- 8. McElvain proposes overhead charges (combined fixed rates) of \$6,000.00 per month while drilling and \$600.00 per month while producing.
- 9. Attachment E is a copy of the authorization for expenditure (AFE) for this well.
  - 14. Attachment F is an affidavit of publication.
- 15. Approval of this application will avoid the drilling of unnecessary wells, will prevent waste, will protect correlative rights, and allow McElvain and the other interest owners in the S/2 of Section 3 an opportunity to obtain their just and fair share of the oil and gas under the subject lands.





This letter is to advise you that McElvain Oil & Gas Properties, Inc. has filed the enclosed application with the New Mexico Oil Conservation Division seeking an order pooling all mineral interests from the surface to the base of the Pictured Cliffs formation in a certain spacing and proration unit, San Juan County, New Mexico.
