1 WHEREUPON, the following proceedings were had at
2 9:59 a.m.:

3 EXAMINER CATANACH: At this time I will call Case
4 13,203, which is the Application of John R. Stearns, d/b/a
5 Stearns, for an unorthodox gas well location, Lea County,
6 New Mexico.

7 Call for appearances in this case.

8 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe,
9 representing the Applicant. I just have a short statement.

10 EXAMINER CATANACH: Okay, Mr. Bruce, you may
11 proceed.

12 MR. BRUCE: Mr. Examiner, this concerns an
13 unorthodox gas well location. The well unit is the east
14 half of Section 16, Township 9 South, Range 37 East, in Lea
15 County. I believe the well, the State 16 Well Number 1 Y,
16 was originally drilled down to the Devonian.

17 Mr. Stearns proposes to recomplete the well in
18 the Morrow formation. The east half would be dedicated to
19 the well.

20 It is at an unorthodox location, 330 feet from
21 the south line and 940 feet from the east line. The
22 Application was originally filed administratively, and
23 notice was given to the affected offsets in the north half
24 of Section 21, who are all unleased mineral owners.

25 One of them objected, a Mr. Richard Donald Jones,

1 Jr. As a result, Mr. Stogner set this matter for hearing.

2 Notice has been given again to all of the
3 offsets, and that is reflected in Exhibit 1, the notice
4 affidavit. I'd ask that that be accepted into evidence.

5 No one has shown up at the hearing other than me,
6 and I would request that since there is apparently no
7 objection at this time, that this matter be referred back
8 to the administrative docket and an unorthodox location
9 order issued.

10 EXAMINER CATANACH: Okay, Exhibit 1 will be
11 admitted in this case.

12 Mr. Bruce, shall we leave the case -- How should
13 we dispense with the case?

14 MR. BRUCE: I would request that the case not be
15 finally dismissed until an administrative order is issued.

16 EXAMINER CATANACH: So you would request,
17 therefore, a continuance?

18 MR. BRUCE: A continuance, why not for four
19 weeks?

20 EXAMINER CATANACH: Which would be to February --

21 MR. BRUCE: -- 5th, I believe.

22 EXAMINER CATANACH: Okay, and is Mr. Stogner
23 aware of this situation?

24 MR. BRUCE: I will --

25 EXAMINER CATANACH: Okay, so you'll discuss that

1 with him and explain it to him?

2 MR. BRUCE: Yes, sir.

3 EXAMINER CATANACH: Okay. I don't think we need
4 to do anything else.

5 This case, Case 13,203, will be continued to
6 February 5th, and the Application will be referred back to
7 the Division for administrative approval.
