APPLICATION OF THE NEW MEXICO OIL CONSERVATION DIVISION, THROUGH THE ENFORCEMENT & COMPLIANCE MANAGER, FOR A COMPLIANCE ORDER AGAINST OPERATOR DENNIS LANGLITZ, REVOKING OPERATOR'S AUTHORITY TO INJECT INTO HIS WELLS, AND PURSUANT TO NMSA 1978, SECTION 70-2-14(B) ORDERING OPERATOR TO PLUG AND ABANDON ALL WELLS HE OPERATES IN NEW MEXICO BY A DATE CERTAIN AND AUTHORIZING THE DIVISION TO PLUG SAID WELLS AND FORFEIT THE APPLICABLE FINANCIAL ASSURANCE IN THE EVENT OF NON-COMPLIANCE; EDDY COUNTY, NEW MEXICO.

**UNOPPOSED MOTION FOR CONTINUANCE**


Dennis Langlitz ("Langlitz") moves for a continuance of the hearing in this matter. In support of his motion, Langlitz states:

1. This matter is presently set for hearing on December 17, 2009.
2. Events have transpired since the Division's Enforcement and Compliance Manager filed his Application for a Compliance Order that in all likelihood will result in a change in Langlitz's status as an operator of record of wells in New Mexico. Langlitz has entered into a transaction that involves the purchase and sale of all his New Mexico oil and gas wells and related assets, and the purchaser will be requesting the Division's approval of a change of operator for the wells.
3. Accordingly, Langlitz requests a continuance of the hearing until January 21, 2010, to give his purchaser sufficient time to obtain Division approval of the change of operator for all of Langlitz's New Mexico oil and gas wells.
4. Counsel for the Division does not oppose this motion.

WHEREFORE, Langlitz requests that the hearing in this matter be continued until January 21, 2010.


