Burlington Resources Oil & Gas Company LP (hereinafter referred to as "Burlington") proposes to drill, complete and produce each of the two referenced wells for downhole commingled production from the Mesaverde and Dakota formations. I have enclosed a ballot and cost estimates for each well for your review and approval.

Our records indicate that you own a working interest in the above referenced lands as summarized in Exhibit "A" attached to the enclosed A.A.P.L. Form 610-1982 Model Form Joint Operating Agreement ("JOA"), dated April 1, 2010. Also enclosed are a Memorandum of Operating Agreement and a Communitization Agreement for your review and execution.

There does not appear to be an Operating Agreement covering the Dakota formation for this 326.92-acre spacing unit covering the referenced lands. As for the Mesaverde formation, I have found a Gas Operating Agreement dated May 19, 1952 for the initial well known as the State Com #1 drilled May 26, 1952 and plugged January 21, 1971. There are also two additional wells, the State Com #1Y drilled in January 1971 and the State Com SRC #1A drilled in July 1977. Both wells are still producing from the Mesaverde formation and presumably were drilled based upon the 1952 agreement.

Because this 1952 agreement does not provide for the drilling of these two new proposed wells and because the New Mexico Oil Conservation Commission, in 2002, increased the well densities for both the Dakota and Mesaverde formations, Burlington proposes to drill these two new wells and any subsequent wells drilled to the Dakota and/or Mesaverde formation pursuant to the enclosed JOA.

Please review the cost estimates, Joint Operating Agreement and Memorandum of Operating Agreement and, if you are in accordance, please execute and return a copy of the following:


1. A copy of the signature page to the Operating Agreement
2. A copy of the notarized signature page to the Memorandum of Operating Agreement
3. Two (2) copies of the notarized signature page to the Communitization Agreement
4. A copy of the Ballot Letter for each well

Please take notice Burlington has recently approved the 2005 COPAS form for use in the San Juan Basin and it has been attached to the enclosed JOA.

Please be advised that due to the number of owners involved Burlington anticipates filling an application for Compulsory Pooling with the New Mexico Oil Conservation Division. If Burlington has not received an executed signature page to the enclosed JOA prior to June 30, 2010, your interest will be included in the Compulsory Pooling.
