

APPLICATION

Read & Stevens, Inc. applies to re-open Case No. 12733-A, and for an order rescinding or reducing the civil penalty imposed against it by Order No. R-11761, and in support thereof, states:

1. Case No. 12733-A was filed by the Division to require several operators to bring 56 wells into compliance with Division Rule 201.B, and to assess civil penalties for failure to do so.

2. Applicant is the operator of fourteen wells which were the subject of Case No. R-12733-A.

3. Order No. R-11761, issued on April 15, 2002, assessed a civil penalty of \$26,000.00 against applicant for failure to timely bring its wells into compliance with Division Rule 201.B.

4. Applicant's wells have been brought into compliance with Division Rule 201.B, and requiring it to pay the civil penalty will cause waste, and is otherwise improper.

**WHEREFORE**, applicant requests that the civil penalty imposed against it by Order No. R-11761 be rescinded or reduced.
