Gentlemen:

The suspension of operations for the Cat Head Mesa Unit Agreement, Socorro County, New Mexico was approved by our letter dated November 4, 2009. This was a six-month suspension effective November 4, 2009 and terminated May 4, 2010. The suspension that terminated May 4, 2010 included all Federal leases committed to the unit.

Rentals for Federal leases committed to the Cat Head Mesa Unit were due August 31, 2010. The rentals have not been paid therefore the Cat Head Mesa Unit Agreement numbered NMNM-106852-X terminated August 31, 2010. Diligent drilling operations were not pursued in the development of the unit area as defined in the Public Interest Requirement 43 CFR 3183.4(b) therefore the committed Federal leases are considered terminated August 31, 2010. The terminated Federal leases are; NM-91532, NM-91533, NM-91534, NM-91535, NM-91536, NM-91537, NM-91538, NM-91539, NM-91540, NM-91587, NM-93025, NM-93026, NM-93028, NM-93029 and NM-97648. The Federal leases contain a total of 26,499.79 acres more or less.

The Cat Head Mesa Unit No. 4 well located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ , Sec. 23, T. 4 S., R. 9 E., NMPM on Federal Lease NM-91538 was plugged on September 23, 2008 and approved on April 7, 2009. Bond Coverage under your \$25,000.00 Statewide BLM Bond Number NMB000597 will be maintained until surface restoration requirements are completed and final abandonment is approved. The Socorro Field Office should advise the BLM New Mexico State Office when such action has been completed.
