


**AFFIDAVIT OF MICHELE CADWELL**

Michele Cadwell, being first duly sworn on oath, states as follows:

1. I am the age of majority and am otherwise competent to testify to the matters set forth herein.
  
2. I am a petroleum landman employed by EEX Corporation and am familiar with the West Lovington Strawn Unit and the holdings of EEX and GCI in the vicinity of the unit. I am also familiar with the customs and practices of the oil and gas industry and of land professionals with respect to the collection and dissemination of geophysical data. My Curriculum Vitae is attached hereto as Exhibit A.
  
3. EEX owns significant lease interests dedicated to the West Lovington Strawn Unit. Approximately 47% of the working interest participation in the West Lovington Strawn Unit is owned by EEX. In addition, EEX owns or controls acreage outside of the unit acquired by direct lease, farmout or under other acreage agreements. GCI and EEX are presently negotiating for the acquisition of exploration acreage in close proximity to the West Lovington Strawn Unit. I also have direct knowledge that Hanley and Yates are actively competing with GCI and EEX for exploration acreage in the area. Consequently, Yates and Hanley are regarded as direct competitors to GCI and EEX.
  
4. Based on my experience, seismic data have significant value in connection with leasing efforts for exploration acreage and, accordingly, such information is regarded as proprietary and confidential. In this case, the use of seismic data gives GCI and EEX competitive advantage in assembling lease acreage. Moreover, it is probable that the disclosure of the seismic



data will affect the value of lease acreage presently owned by EEX and GCI.

5. The attached Exhibit B lists the record title owners of working interests in those tracts Hanley/Yates propose to include in their application to expand the West Lovington Strawn Unit. Many of the interest owners reflected on Exhibit B are also operators and direct competitors to EEX and GCI for exploratory lease acreage in the area. It is my reading of the April 6, 1998 Commission Order that the EEX/GCI confidential seismic information would be disclosed to these competitors as well.

6. As a result of the disclosure of the seismic information to their competitors, both the competitive advantage and the value of the seismic to EEX and GCI would be destroyed.


