

Dear Mr. Fesmire:

On December 16, 2009, the Division entered Order No. R-13201 which granted the application of Anadarko Petroleum Corporation in the above-referenced case and authorized the injection of acid gas into the Entrada formation through a well to be drilled at a location 1650 feet from the North line and 2310 feet from the West line of Section 1, Township 29 North, Range 15 West, NMPM, San Juan County, New Mexico. The well will be used for the disposing of natural gas processing wastes from Anadarko's San Juan River Gas Plant.

Pursuant to Order R-13201, Anadarko respectfully requests an extension of six months to commence injection operations. See Order Paragraph 18. To date, Anadarko has drilled and completed the well; however, Anadarko is still conducting and reviewing data from pressure and injection flow rate tests on the well. Anadarko will not be ready to commence injection operations in the well until this testing is complete. Therefore, Anadarko hereby requests an extension of Order No. R-13201 from December 16, 2010 until May 16, 2011.
