

We have a letter of protest from BEPCO (Ocean Munds-Dry, Esq.) dated 2/7/06 to this application, therefore, we can not issue a permit administratively, until BEPCO files a letter withdrawing this protest.

Judah oil has 2 of 34 inactive wells, so that is OK. However, it has one well which needs a bond posted with Dorothy Phillips. Any proposed hearing for this matter will be continued until Judah is in compliance with Rule 5.9.
