- 15. CASE 14517: Application of Mewbourne Oil Company for a non-standard spacing and proration unit and compulsory pooling, Eddy County, New Mexico. To: Clifford Cone, Individually and as Trustee of Trusts Created U/W/O & Codicil of Kathleen Cone, Deceased, fob the children of Clifford Cone. Applicant seeks an order (1) creating a 160-acre non-standard spacing unit comprised of the S/2 S/2 equivalent of Section 29, Township 18 South, Range 30 East, NMPM, and (2) pooling all mineral interests in the Bone Spring formation, Santo Nino Bone Spring Pool, in this non-standard spacing and proration unit which spacing unit will be pooled project area for the existing Bradley "29" Federal Com Well No. 1 (API No. 30-015-37481) that will be reentered ate non-standard surface location 1050 feet from the South line and 1905 feet from the East line (Unit O) and then drilled in a westerly direction approximately 3,050 feet in the Bone Spring formation to a terminus 972 feet from the South line and 343 feet from the West line (Unit M) of said Section 29. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of Mewbourne Oil Company as operator of the well and a charge for risk involved in drilling said well. Said area is located approximately 8 miles South of Loco Hills, New Mexico.

CASE 14518: Application of Enstor Grama Ridge Storage and Transportation, L.L.C. for the establishment of pressure limitations for injection wells in the Grama Ridge Storage Area, Lea County, New Mexico. Applicant seeks an order approving the injection and storage and withdrawal of natural gas in the Grama Ridge Storage Area by and through the following wells:
 - A. Grama Ridge Morrow Unit Well No. 001 (API No. 30-025-21336) located 1980 feet from the North line and 660 feet from the West line (Unit E) of Section3, Township 22 South, Range 34 East, NMPM;
 - B. Grama Ridge Morrow Unit Well No. 002 (API No. 30-025-21717) located 1980 feet from the South line and 660 feet from the West line (Unit L) of Section 34, Township 21 South, Range 34 East, NMPM;
 - C. Grama Ridge Morrow Unit Well No. 003 (API No. 30-025-21746) located 1980 feet from the South and East lines (Unit J) of Section 33, Township 21 South, Range 34 East, NMPM (Enstor plans to disconnect this well and use it as an observation well); and
 - D. Grama Ridge Morrow Unit Well No. 004 (API No. 30-025-21334) located 2310 feet from the North and West lines (Unit F) of Section 4, Township 22 South, Range 34 East, NMPM; and
 - E. Grama Ridge Federal 8817-JVP Well No. 1 (API No. 30-025-30686) located 660 feet from the North line and 1980 feet from the East line (Unit B) of said Section 9, Township 22 South, Range 34 East, NMPM.
 - Applicant also seeks an order approving a surface injection pressure limit of 5000 pounds per square inch, guage (psig) for injection wells in the Grama Ridge Storage Area and authorizing an administrative procedure for the addition of injection wells to the Grama Ridge Storage Area without notice and hearing. The Grama Ridge Storage Area is located in Sections 33 and 34 of Township 21 South, Range 34 East and Sections 3, 4, 9 and 10 of Township 22 South, Range 34 East, N.M.P.M. which is located approximately 18 miles West of Eunice, New Mexico.
- 17. CASE 14519: Application of Mewbourne Oil Company for an order authorizing the drilling of a well in the Potash Area, Eddy County, New Mexico. Applicant seeks an order approving the drilling of its proposed Parkway "26" State Com Well No. 3H as a horizontal well in the Potash Area from a standard surface location 2240 feet from the North line and 330 feet from the West line (Unit E) of Section 26, Township 19 South, Range 29 East, NMPM, to a depth of 12,500 feet (true vertical depth of approximately 8,200 feet subsurface) and then in an easterly direction in the Bone Spring formation, Turkey Track-Bone Spring Pool (Pool Code 60660), to a bottom hole terminus at a location 2240 feet from the North line and 330 feet from the East line of said Section 26. The project area for this horizontal well will be the S/2N/2 of Said Section 26. Said location is within the Potash Area and located approximately 13 miles Northeast of Carlsbad, New Mexico.
- 18. **CASE-14520**, Application of Lynx Petroleum Consultants, Inc. for an order authorizing the drilling of a well in the Potash Area, Eddy County, New Mexico. Applicant seeks an order approving the drilling of its proposed Eddy "BD" State Well No. 3 within the Potash Area at a location 1980 feet from the North line and 1980 feet from the East line (Unit G) of Section 32, Township 20 South, Range 30 East, NMPM, Eddy County, New Mexico. This well will be drilled to an approximate depth of 11,500 feet to test all formations from the surface to the Strawn formation, Golden Lane Strawn Pool and will be at a standard location in all formations. Said location is within the Potash Area and located approximately 14 miles Northeast of Carlsbad, New Mexico.
