Under the terms of the governing Operating Agreement, Mewbourne hereby proposes to drill the captioned well at the referenced surface location (SL) to the referenced bottom hole location (BHL). The proposed well will be drilled to a true vertical depth (TVD) of approximately 2,740 feet subsurface to evaluate the Yeso formation for oil production. The proposed well will have a horizontal measured depth (MD) of approximately 6,508 feet. The E/2NW/4 and the NE/4SW/4 of the captioned Section 24 will be dedicated to the well as the oil proration unit.

Regarding the above, enclosed for your further handling is our AFE dated December 20, 2010 for the captioned well. In the event your firm elects to participate in the captioned proposed well, please have the enclosed AFE executed and return to me within thirty (30) days.

Per our conversation, I just wanted to give you a heads up and let you know we are going to go ahead and commence compulsory pooling for the Wyatt Draw 24 KC #1H Well in the next week or so. I hate to rush you through your election period, but we have an obligation date we must meet on a BP lease in the S/2 of Section 24. I have to get it ready. We currently have this well set to spud mid February and do not have much wiggle room on our drilling schedule. I have spoken with all the other parties involved and they are expediting their respective elections. Nearburg is the only party not subject to the Operating Agreement.
