

MINERAL DEED

) KNOW ALL MEN BY THESE PRESENTS:

That Robert W. Westfall, as Personal Representative of the Estate of Archie Westfall, Deceased, No. PB-2004-00442, in the Second Judicial District Court, Bernalillo County, New Mexico (hereinafter called "Grantor"), of Bernalillo County, New Mexico, as a partial distribution from the Estate, has granted, sold, conveyed, assigned and delivered, and by these presents does grant, sell, convey, assign and deliver unto Robert W. Westfall, a married man, as his sole and separate property (hereinafter called "Grantee"), whose address is 1329 Sigma Chi Road NE, Albuquerque, New Mexico 87106, an undivided 82/306.47th interest in and to all of the oil, gas and other minerals in and under, and that may be produced from the following described land situated in Rio Arriba County, New Mexico, to-wit:

Tract No. 41 in Township Twenty-nine (29) North, Range Six (6) West, N. M. P. M., containing 145.23 acres;

Lots Six (6), Seven (7), Eleven (11), Twelve (12), South half of the Southwest Quarter (S $\frac{1}{2}$ SW $\frac{1}{4}$) and Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 4; the Southeast quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) and the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 5; the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 9, all in Township Twenty-nine (29) North, Range Six (6) West, N. 
