
Ladies and gentlemen:

Enclosed is a copy of an application for an unorthodox well location, *etc.*, filed with the New Mexico Oil Conservation Division by Mewbourne Oil Company, regarding the N½S½ of Section 30, Township 18 South, Range 30 East, N.M.P.M., Eddy County, New Mexico. 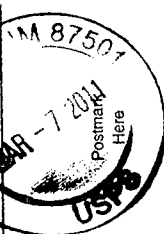
