STATEMENT OF THE CASE

INTERESTED PARTY:

- (1) Williams is the applicant before the New Mexico Oil Conservation Division in the referenced case and seeks approval to increase the well density in the Rosa Unit for wellbores completed in the Mesaverde formation from the current four wellbores per 320-acre gas spacing unit to not more than eight wellbores.
- (2) ConocoPhillips, an offsetting operator to the Rosa Unit, seeks a one-half mile "buffer zone" so that any increased Mesaverde density wells within the Rosa Unit will not be drilled closer than one-half mile to the outer boundary of this unit for the ConocoPhillips operated properties
- (3) ConocoPhillips is neither for nor against the requested increased density for the Rosa Unit provided that the Division adopts this "buffer zone."
- (4) The agreed buffer zone that addresses ConocoPhillips' concerns about its correlative rights, and possible unnecessary wells but still allow Williams to more forward with its application.
