



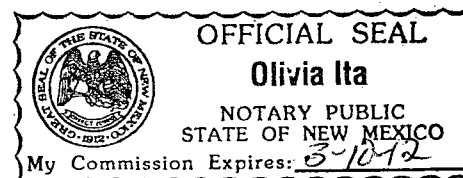

Re: Application of Mewbourne Oil Company for a non-standard spacing and proration unit, unorthodox well location, and compulsory pooling, Eddy County, New Mexico.


Ladies and Gentlemen:

This letter is to advise you that Mewbourne Oil Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking an order creating a non-standard spacing unit comprised of the W/2 SW/4 of Section 13, Township 19 South, Range 25 East, NMPM; and pooling all mineral interests in the Yeso formation, North Seven Rivers-Glorieta-Yeso Pool, in this non-standard spacing and proration unit which spacing unit will be the project area for its proposed Wyatt Draw "13" ML No. 1H Well to be horizontally drilled from a surface location 250 feet from the North line and 350 feet from the West line of Section 24 and then in a northerly direction in the Yeso formation, to a bottom hole terminus at a location 2310 feet from the South line and 350 feet from the West line of Section 13, all in Township 19 South, Range 25 East. This well will penetrate the Yeso formation at an unorthodox location 250 feet from the North line and 350 feet from the West line of Section 24, however, the producing interval in the wellbore is within the well's "producing area."

This application has been set for hearing before a Division Examiner at 8:15 AM on March 31, 2011. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 1208.B to file a Pre-Hearing Statement with the Oil Conservation Division's Santa Fe office, four days in advance of a scheduled hearing, but at least on the Thursday preceding the hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.
