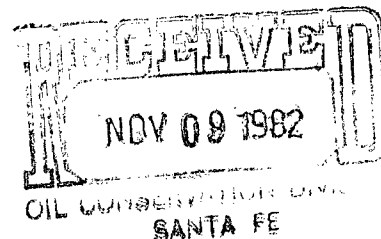

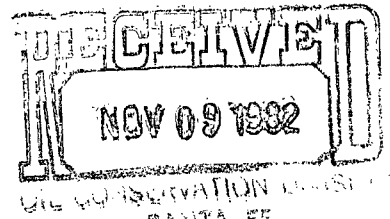

APPLICATION

Clements Energy, Inc. by its undersigned attorneys, hereby makes application for an Order pooling all interests in the Pennsylvanian formation underlying the NE $\frac{1}{4}$  Section 14, Township 14 South, Range 34 East, N.M.P.M., Lea County, New Mexico, and in support thereof would show:

1. Applicant is entitled to proceed with the drilling of a well located in the NE $\frac{1}{4}$  of Section 14, Township 14 South, Range 34 East, N.M.P.M., Lea County, New Mexico, under the authority of Applicant's ownership of an oil and gas leasehold interest in E $\frac{1}{2}$ NE $\frac{1}{4}$ , SW $\frac{1}{4}$ NE $\frac{1}{4}$  of said Section 14.

2. Applicant proposes to drill its State - 14 Well #1 660 feet from the North line and 660 feet from the East line of said Section 14, to a depth sufficient to test the Pennsylvanian formation and seeks to dedicate the NE $\frac{1}{4}$  of Section 14 to the well. Applicant requested the party shown on the attached statement as the owner of an oil and gas leasehold interest in NW $\frac{1}{4}$ NE $\frac{1}{4}$  Section 14 to agree to sell, to participate in the drilling of said well, to farmout or otherwise commit his interest to said well, but the party so far has refused to do so.

3. Applicant asks that the Division consider the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of applicant as operator of the well and a charge for risk involved in drilling said well.

4. The pooling of all interests in the Pennsylvanina formation in NE $\frac{1}{4}$  Section 14 will avoid the drilling of unnecessary wells, prevent waste and protect correlative rights.

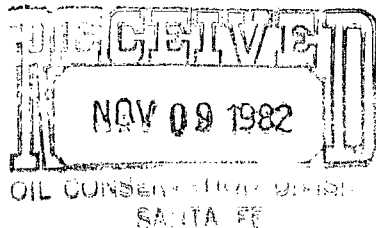
5. Applicant respectfully requests the setting of this matter before the Division at its regular hearing on November 23, 1982.

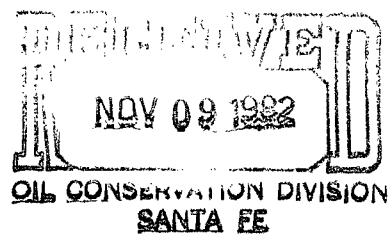
