1 EXAMINER EZEANYIM: This hearing will come  
2 to order. Good morning everybody. I'd really like to  
3 use this opportunity to welcome all of you to our hearing  
4 in Santa Fe. It's an honor to have you all.

5 First, I know there are a lot of new people  
6 here. If you have a business card, please give it to the  
7 court reporter so she can spell your name correctly and  
8 so we can have them in the record.

9 My name is Richard Ezeanyim. I'm going to be  
10 the Technical Examiner today. At my left is David  
11 Brooks. He's going to be the Legal Examiner.

12 As you know, today is April 14th, for the  
13 record, and it's approximately 8:15 in the morning. We  
14 are today going to conduct Docket Number 9-11.

15 The first order of business is, first of all,  
16 we are going to read out all the continuances and  
17 dismissals starting with page 1. On page 1, Case Number  
18 14522 is continued to April 28; Case Number 14576 is  
19 continued to April 28.

20 On page 2, Case Number 14602 is continued to  
21 April 28; Case Number 14614 is continued to April 28;  
22 Case Number 14615 is continued to April 28; Case Number  
23 14620 is continued to April 28; Case Number 14621 is  
24 dismissed.

25 Now, it's interesting, if you turn to page 3,

1 all the cases on that page were continued to April 28,  
2 and I'm going to read the case numbers for the record.  
3 Case Number 14623, Case Number 14624, Case Number 14625,  
4 Case Number 14626, Case Number 14627, Case Number 14628.  
5 All these cases are continued to April 28.

6 On page 4, Case Number 14551 is continued to  
7 April 28; Case Number 14566 is continued to April 28.  
8 Case Number 8352 is an old case. It's continued to April  
9 28. We need to get it off the docket.

10 EXAMINER BROOKS: If we don't get that  
11 case to hearing, I'm going to have to write an order in  
12 the compulsory pooling case. It's going to be a year  
13 old.

14 MS. MUNDS-DRY: I'll bring that to  
15 Mr. Carr's attention.

16 EXAMINER EZEANYIM: We need to dispose of  
17 that case.

18 MS. MUNDS-DRY: It's old, like him,  
19 Mr. Ezeanyim.

20 MR. BRUCE: Get that on the record.

21 EXAMINER EZEANYIM: Now I'm going to go  
22 back to page 5. Case number 14583 is continued to April  
23 28; Case Number 14569 is continued to April 28.

24 Then the last page, page 6, Case Number ~~14570~~  
25 is continued to April 28.

1 Are there any other continuances or dismissals  
2 at this point?

3 What I think I would like to do this  
4 morning, first I would like to open Case Number 14613. I  
5 know a lot of people are interested in that. People come  
6 from all over the place to participate in that case, and  
7 that's interesting.

8 After that we'll go to Case Number 14605,  
9 14619 and 14622. I hope that there's no extenuating  
10 circumstances with the way we are going to proceed today.

11 MR. BRUCE: Mr. Examiner, since I'm the  
12 odd man out today, I wondered if Case 14622 could go  
13 first. It will take about two or three minutes. It's an  
14 affidavit case.

15 EXAMINER EZEANYIM: Is there any objection  
16 to that? I don't mind.

17 MS. MUNDS-DRY: Counsel does haven't any  
18 objection.

19 EXAMINER EZEANYIM: We can go to that. I  
20 think that's a good point, so we can let you go. Okay.  
21 I'll change my order a little bit.


