1. ***CASE 14630: (Continued from the April 28, 2011 Examiner Hearing.)***  
***Application of Lime Rock Resources A, L.P. for compulsory pooling and non-standard spacing and proration unit, Eddy County, New Mexico.*** Applicant seeks an order pooling all mineral interests from the surface of the earth to test the Cherry Canyon formation underlying the S/2 SW/4 of Section 10, Township 25 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. Applicant proposes to horizontally drill its Shrike State Well No. 2 H to be located at a surface location of 400 FSL and 2590 FWL and bottom hole location of 400 FSL and 330 FWL of said Section 10. Applicant seeks to dedicate the S/2 SW/4 of Section 10 to the well to form a non-standard 80 acre spacing and proration unit for any formations and/or pools developed on 80 acre or less within the vertical extent, including the Cherry Canyon formation. The subject lands are located approximately 6 miles South of Malaga, New Mexico.
2. ***CASE 14637: (Readvertised)***  
***Application of OGX Resources LLC for approval of a non-standard oil spacing and proration unit and compulsory pooling, Eddy County, New Mexico.*** OGX Resources LLC seeks an order approving a 185.60-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of Lot 7 and the NE/4 NE/4 of Section 31 and the SE/4 NE/4 and E/2 SE/4 of Section 30, Township 26 South, Range 29 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the non-standard spacing and proration unit (project area) for all pools or formations developed on 40 acre spacing within that vertical extent. The unit is to be dedicated to the Copperhead 31 Fed. Com. Well No. 1, a horizontal well with a surface location in Lot 7 of Section 31, and a terminus in the SE/4 NE/4 of Section 30. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The unit is located approximately 1 mile Northeast of the intersection of U.S. Highway 285 with the Texas state line.
