
The Commissioner of Public Lands has, of this date, approved the above-captioned Plan of Development. Our approval is subject to like approval by all other appropriate agencies.

We are in receipt of your letter of October 6, 2003 together with the commerciality determination data for 113 Rosa Unit wells recently completed in the Fruitland Coal formation.



The Rosa Unit Well Nos. 212, 222, 226, 234, 235, 239, 258, 261, 264, 283, 284, 287, 288, 293, 294, 296, 297, 298, 305, 306, 308, 309, 310, 311, 312, 313, 315, 322, 332, 335, 336, 344, 351, 359, 500, and 63 are non-commercial in the Fruitland Coal formation and should be produced on a lease basis.

Please be advised that the Commissioner of Public Lands concurs with the Bureau of Land Management's commerciality determinations for the above-mentioned Rosa Unit Wells. The wells determined commercial are to be included in the Fruitland Coal participating area. The wells that were determined to be non-commercial are to be reported on a lease basis.
