



Devon Energy Production Company, L.P. ("Devon"), as unit operator, on behalf of itself and all owners of oil and gas leases within the Northeast Blanco Unit, hereby submits **Revision No. 3** to the 2003 Plan of Development. This Revised 2003 Plan of Development is identical to the 2003 Plan of Development dated January 27, 2003, **Revision No. 1** to the 2003 Plan of Development dated February 18, 2003, and **Revision No. 2** to the 2003 Plan of Development dated May 20, 2003, with the following exceptions:
